## Understanding Mobipocket Reader for BOOKMAN

With Mobipocket Reader, you can read eBooks, eNews and eDocs stored on your Expansion Card. The Reader gives you the option of toggling between right and left justification and small and large fonts. Mobipocket Reader comes with online help that you can view at any time by pressing **HELP**.

### Key Guide

#### Function Keys

These are physical keys on the handheld device.

| <b>ENTER</b> | Selects an eBook at the Library, highlights a link or finds an Index entry's corresponding text. |
| <b>BACK</b>  | Erases the letters at the search screen or backs up to the previous link.                        |
| <b>CLEAR</b> | Goes to the current eBook's Table of Contents.   |
| <b>HELP</b>  | Displays the help file.  |
| <b>MENU</b>  | Goes to the Library.   |

## Touch Keys

These keys are displayed at the bottom of the screen and must be touched to activate.

**EBOOKS** Goes to the Library.


**TOC** Goes to the current eBook's Table of Contents.

**FONT** Toggles between small and large fonts.

**JUST** Toggles between left-aligned and full text justification.

**FIND** Goes to the Index, if available.

## Using Mobipocket Reader

1. Press **CARD** on your handheld device.
2. Use the right or left arrow to highlight  and press **ENTER** to select it.  
You go the Library.
3. Use the up or down arrow to highlight the book you want and press **ENTER** to select it.
4. Use the up or down arrow or **SPACE** to scroll.  
An underline indicates linked text.
5. Press **ENTER** to select the first link.
6. Use the left or right arrow to highlight the link you want.
7. Press **ENTER** to go to the linked location.
8. To exit Mobipocket Reader press **CARD** and make another selection.
